KNOW ALL to whom there present shall come that I/We _____ do hereby appoint DHEERAJ JAIN, Advocate [BA (Law) LLB, LLM], Kothi No. 2224, Sector 15-C, Chandigarh-160015 (hereinafter called 'the Advocate') to be my/our advocate in the above noted case and authorise him:-

To act, appear and plead in the above-noted case in this court or in any other court in which the same may be tried or heard and also in the appellate court, subject to payment of fees separately for each court by me/ us,

To deposit, draw or receive moneys and grant receipts thereof, and to do all other acts and things which may be necessary to be done for the progress and in the course of the prosecution of the said case,

To appoint and instruct any other legal practitioner, authorizing him to exercise the power and authority hereby conferred upon the Advocate whenever he may think fit to do so,

And I/We, the undersigned, do hereby agree to ratify and confirm all acts done by the Advocate or his substitute in the matter as my/our own acts, as if done by me/us for all intents and purposes,

And I/We, the undersigned, do hereby agree that in the event of the above noted case being taken up on tour, I/We shall pay extra fees,

And I/we, the undersigned, do hereby agree not to hold the Advocate or his substitute responsible for the result of the said case in consequence of their absence from the court when the said case is called up for hearing, or for any negligence of the Advocate or their substitute,

And I/we, the undersigned, do hereby agree that in the event of the whole or part of the fee agreed by me/us to be paid to the Advocate remaining unpaid, he shall be entitled to withdraw from the prosecution of the case until the same is paid up. If any cost is allowed for an adjournment or otherwise, the Advocate would be entitled to the same,

And I/We, the undersigned, do hereby agree that once the fee is paid to the Advocate, I/we will not be entitled for the refund of the same in any case whatsoever.
